



MEMBERSHIP APPLICATION

New members are selected by an Art Jury once a year on the first Thursday in May. Applicants are required to submit three (3) examples of their actual work for review by the Art Jury comprised of five members annually elected by the membership. Membership is determined by secret voting and is based on originality, continuity and professional quality.

DATES

Women Painters West will hold the next Art Jury membership screening on Thursday, May 4, 2017. Application deadline is April 15, 2017.

ELIGIBLE ARTWORK

Works should be of professional quality, original in concept and execution. Copies and works done under the supervision of an instructor in a student class or workshop are ineligible. It is suggested that you submit related works, such as a series, to offer the best understanding of your level of accomplishment to the jurors. Oils, acrylics, watercolors, mixed media, printmaking, collages and digital fine art are all acceptable media. However, a "Giclee" digital print may not be submitted unless the print has been extensively altered (i.e. must be one-of-a-kind work). Maximum frame size is 50" in any direction. All work must be hand-delivered and picked up.

FRAMING

Art submitted, but not properly framed will not be accepted. Canvas works may be without a formal frame, but all edges must be finished in a manner appropriate to the painting and contain no visible staples. Works that need protection should be under Plexiglas®. Glass may be used only when work measures no more than 18" x 24" (432 sq.in.) All framing should be of gallery quality and presented in a professional manner. Please keep in mind that your framing decisions contribute to the overall presentation of your work and will be taken into consideration by jurors.

Directions to the Jury Site for Women Painters West

Please deliver your work to the Community Room of St. Bede's Church. There is ample off-street parking in the Church lot, on the NE corner of Grand View Blvd. & Charnock Road.

DIRECTIONS from the SAN FERNANDO VALLEY:

Take the 405 FWY. SOUTH to the 10 FWY. West. Stay in the right lane and take the SECOND exit, BUNDY SOUTH. Proceed approximately 2 miles to the signal at CHARNOCK ROAD. TURN LEFT. Proceed 2 blocks to GRAND VIEW BLVD. The Church is on the NORTHEAST corner.

DIRECTIONS from the EAST:

Take the 10 FWY. Exit on BUNDY SOUTH. Proceed as above.

DIRECTIONS from the SOUTH BAY:

Take the 405 FWY. NORTH. Take VENICE BLVD. EXIT. TURN LEFT onto SEPULVEDA BLVD. Turn LEFT onto VENICE BLVD. Proceed WEST about 1 mile to the signal at GRAND VIEW BLVD. Turn RIGHT. Proceed to the corner of CHARNOCK ROAD. The Church is on the NE corner.
