RULES OF ENTRY REQUIREMENTS....PLEASE READ COMPLETELY

- Work must be your own original artwork, not done under an instructor's supervision, and not exhibited in any previous WPW show.

Think back and remember....this show's theme can be your personal interpretation.

SPECIFICATIONS

- Work does not have to be for sale.
- Original digital art will be considered but not digital reproductions.

ACCEPTED WORK

- No more than **THREE** entries by any single artist.
- Not more than **TWO** entries per artist will be accepted.
- WPW reserves the right to reproduce accepted artwork for publicity and documentation purposes.
- The artist retains all copyrights in the artwork.

ENTRY PROCEDURE

Artwork for consideration by juror must be entered in the **OnlineJuriedShows.com** website by **midnight Sunday, March 5, 2023.**

FEES

\$35 for ONE entry, **\$5** for each additional entry, up to **three** total entries by a single artist. All fees must be paid by the entry deadline and are non-refundable and payable through the OnlineJuriedShows.com website. Credit card or PayPal are accepted.

The images from this Exhibit to be displayed on the WPW website are the exclusive property of the individual artists and no rights are conveyed to anyone without the express written permission of the artist.

Entries not meeting the criteria listed will be disqualified and the entry fee will not be refunded.

DIGITAL IMAGES OF EACH PIECE

- Digital format: JPEG
- Entry form must be filled out in its entirety. List sizes up to the nearest inch. Submitted images must not include matting or frame. Crop the photos to include only the artwork. Be sure your images are right side up.
- Before uploading your images, make sure they are smaller than 4MB, but at least 1920 pixels on the longest side at 72 dpi. Images should be in JPEG (.jpg) format, sRGB color space. Help photographing your work and properly sizing your images can be found at: www.onlinejuriedshows.com/help.aspx.
- Please add Services@OnlineJuriedShows.com and Manager@OnlineJuriedShows.com to your safe senders list to ensure notifications are received

Go to www.onlinejuriedshows.com to submit your entry. If you do not have an account, you will need to set one up. Follow the instructions on the screen. Use images you have on your computer to submit your entry.
