Acceptance Notification:	Friday, April 18, 2025
Delivery of Artwork to Gallery:	Monday, April 28, 2025, before 1pm
Opening Reception:	Friday, May 2, 2025, 7-9pm
Exhibit Closes:	Friday, May 23, 2025
Artwork Pickup:	Thursday, May 22, 2025, after 5-7pm Friday, May 23, 9am-12pm

The theme, *“Shades of Color”* leaves room for wide interpretation. Let your creative juices flow!!

A juror (to be determined) will select 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> place winners and three Honorable Mentions.

1<sup>st</sup> prize: \$300  
2<sup>nd</sup> prize: \$200  
3<sup>rd</sup> prize: \$100.

### **Eligibility:**

Work must be your own original artwork, not done under an instructor's supervision, and **not exhibited in any previous WPW show.**

### **Specifications:**

Work must be for sale. Work sold at the exhibit will incur a **25% commission. which goes to The Burbank Fine Art Federation.**

Accepted work must be signed by the artist. Submissions must include artist name, email address, phone number, title of work, medium, dimensions, retail price. No more than 2 works to be selected by juror by any single artist.

### **Liability**

Women Painters West or The Betsy Lueke Creative Arts Center or the City of Burbank shall not be responsible for loss, theft or damage of artworks while in the gallery's possession or in transit. By entering this show, artists agree to all conditions in this Prospectus.

- Work should have simple narrow neutral frames and mats only, or be gallery wrapped.
- Wiring must be in good condition and substantial enough for the weight of the artwork. Wiring must be wrapped with tape at ends. No saw-tooth hangers. All artwork should be ready to hang on the wall for the exhibition.
- All works on paper must be covered with glass or plexiglass.
- All work should be 2-dimensional in any medium.
- Canvas edges should be painted if no frame.
- Delivered work must match the image submitted. No substitutions of accepted works will be allowed.
- All accepted work must remain in the gallery for the duration of the exhibit.
- Prices may not be changed after acceptance.
- Original digital art will be considered but no AI work or digital reproductions.
- Attach a label to the back upper right corner of each piece and have a signed release form to give at take-in. See Page 3 for labels.

### **Entry Procedure:**

Artwork for consideration by jurors must be entered in the [www.onlinejuriedshows.com](http://www.onlinejuriedshows.com) website by midnight Sunday, April 13, 2025.

**Fees:**

**\$35 for two** entries, **\$5** for each additional entry, up to **three** total entries by a single artist. All fees must be paid by the entry deadline and are non-refundable and payable through [www.onlinejuriedshows.com](http://www.onlinejuriedshows.com). Credit card or PayPal are accepted.

The images from this exhibit to be displayed on the Women Painters West and Betsy Lueke Creative Arts Center websites are the exclusive property of the individual artists and no rights are conveyed to anyone without the express written permission of the artist.

**Digital Images of Each Piece:**

Digital format: JPEG

Entry form must be filled out in its entirety. List sizes up to the nearest inch. Submitted images must not include matting or frame. Crop the photos to include only the artwork. Be sure your images are right side up. Before uploading your images, make sure they are smaller than 4MB, but at least 1920 pixels on the longest side at 72 dpi. Images should be in JPEG (.jpg) format, sRGB color space.
